

SIM-PATIA SOCIAL COOPERATIVE – COOPERATIVE COMPANY POLICY PROVIDED PURSUANT TO ARTS. 13 AND 14 OF EU REGULATION 2016/679.

PURPOSE AND METHODS OF THE TREATMENT FOR WHICH THE DATA ARE INTENDED

The subscriber's data will be processed by **Sim-patia Social Cooperative – Cooperative Company** for the following purposes:

A – Providing services and services for the correct and complete execution of the assignment received (effective management of relations between the parties, contract management, management of services provided, and/or management of existing commercial relationships in the exchange of goods and/or products and/or services, invoicing, and related accounting and/or tax obligations);

The processing of your data will be based on principles of correctness, lawfulness, and transparency and can be achieved by means of operations or a set of operations as provided for by articles 5–6 of Regulation (EU) 679/2016. The operations can be carried out with or without the aid of electronic or automated processes, in compliance with the security measures pursuant to Art. 32 of the GDPR 2016/679.

THE OBLIGATORY OR OPTIONAL NATURE OF THE PROVISION OF DATA

The provision of personal data is necessary for the formalization and execution of the existing relationship between the parties and for the execution of the obligations arising from it; any refusal to provide personal data may make it impossible to conclude the existing relationship between the parties and/or the execution of the requested services.

PROCESSING DURATION

The retention period of the data acquired for purpose A is established for a period of time equal to the duration of the contract and, in any case, not exceeding the achievement of the purposes for which they are collected and processed and in compliance with the times prescribed by law (i.e., for no more than 10 years from the termination of the relationship for the purpose of service).

Once these terms have elapsed, the Data will be either destroyed or made anonymous.

TRANSFER OF DATA ABROAD

Personal data is stored on servers located within the European Union (in any case, it is understood that the Data Controller, if necessary, will have the right to move the servers even outside the EU). It should be noted that the use of Google Drive or Dropbox may involve the transfer of data abroad (both EU and non-EU).

The personal data communicated may be transferred to EU countries and/or to third countries with respect to the EU or to an international organization, within the scope of the purposes referred to in the introduction, in compliance with the applicable legal provisions.

THE SUBJECTS TO WHOM THE DATA MAY BE COMMUNICATED

Where necessary, the communication of data will be made only to competent authorities, insurance companies, correspondents, and/or subjects for whom the transmission of data is necessary in relation to the conclusion of the relationship between the parties and use of the related services; in any case, without the need for express consent, the Data Controller may communicate your data to Supervisory Bodies, Judicial Authorities and all those subjects to whom the communication is mandatory by law.

Personal data is not subject to disclosure.

The data may be processed by personnel specifically appointed by the Data Controller only if the processing is necessary for the performance of their duties.

RIGHTS OF THE INTERESTED PARTY

At any time, the interested party may exercise their rights in accordance with the provisions of Articles 15-21 of the (EU) Regulation, namely:

1. ask for confirmation of the existence or otherwise of your personal data;

2. obtain information about the purposes of the processing, the categories of personal data, the recipients or categories of recipients to whom the personal data have been or will be communicated and, when possible, the retention period;

3. obtain the rectification and cancellation of data;

4. obtain the limitations of the treatment;

5. obtain data portability, i.e., receive them from a data controller, in a structured format, commonly used and readable by an automatic device, and transmit them to another data controller without impediments;

6. oppose the treatment at any time, including in the case of treatment for direct marketing purposes;

7. oppose an automated decision-making process relating to individuals, including profiling;

8. ask the data controller to access personal data and correct or cancel them, limit their processing, or oppose their processing, in addition to the right to data portability;

9. revoke the consent at any time without prejudice to the lawfulness of the treatment based on the consent given before the revocation;

10. lodge a complaint with a supervisory authority.
