### THE SUBJECTS TO WHOM THE DATA MAY BE COMMUNICATED

Where necessary, the communication of data will be made only to competent authorities, insurance companies, correspondents, and/or subjects for whom the transmission of data is necessary in relation to the conclusion of the relationship between the parties and use of the related services; in any case, without the need for express consent, the Data Controller may communicate your data to Supervisory Bodies, Judicial Authorities and all those subjects to whom the communication is mandatory by law. adequate security guarantees are provided by the Data Controllers and Managers involved.

### PROCESSING DURATION

The data collected will be kept for a period of time not exceeding the achievement of the purposes for which they are processed (Article 5 of the GDPR) and/or for the time necessary for legal obligations, in any case not beyond the withdrawal of consent by the interested party. Once these terms have elapsed, the Data will be either destroyed or made anonymous.

## **RIGHTS OF THE INTERESTED PARTY**

(Articles 15-21 EU Regulation 679/2016)

At any time, the interested party may exercise their rights in accordance with the provisions of Articles 15-21 of the (EU) Regulation, namely:

1. ask for confirmation of the existence or otherwise of your personal data;

2. obtain information about the purposes of the processing, the categories of personal data, the recipients or categories of recipients to whom the personal data have been or will be communicated and, when possible, the retention period;

3. obtain the rectification and cancellation of data;

4. obtain the limitations of the treatment;

5. obtain data portability, i.e., receive them from a data controller, in a structured format, commonly used and readable by an automatic device, and transmit them to another data controller without impediments;

6. oppose the treatment at any time, including in the case of treatment for direct marketing purposes;

7. oppose an automated decision-making process relating to individuals, including profiling.

8. ask the data controller to access personal data and correct or cancel them or limit their processing, or oppose their processing, in addition to the right to data portability;

9. revoke the consent at any time without prejudice to the lawfulness of the treatment based on the consent given before the revocation;

10. lodge a complaint with a supervisory authority.
