### **POLICY ON NAVIGATION AND COOKIES ON THE WEBSITE**

This Notice broadly describes the practices we have adopted.

This page describes how to manage the site with reference to the processing of personal data of users who consult it. The treatment is always based on principles of lawfulness and correctness in compliance with all current regulations, and suitable security measures are adopted to protect the data.

This privacy policy is also given as a brief information pursuant to Article 13 of Legislative Decree 196/2003 and pursuant to Art. 13 GDPR 679/2016 European Regulation on Privacy, as well as pursuant to the Provision regarding Cookies n. 229 of May 8, 2014. We wish to inform site visitors about the use of the data entered and the cookies used by the site itself.

We inform you that the data collected with the registration of your name or retrieved by us through the consultation of public registers, lists, or documents known to anyone will be subject to treatment in compliance with the aforementioned provisions and the confidentiality obligations that inspire the activity of the **Sim-Patia Social Cooperative**.

The treatments carried out by the **Sim-Patia Social Cooperative** will be based on principles of correctness, lawfulness, transparency, and protection of your privacy and your rights.

The data will be used for commercial, promotional, and advertising purposes, as well as for management purposes by statisticians. Personal data is processed by us lawfully, fairly, and with the utmost confidentiality. They are recorded, organized, and kept in computer and/or paper archives. The data may be communicated by us to our commercial network, to administrative or commercial consultants, to carriers for the delivery of goods or illustrated material, and to parent, subsidiary, and investee companies.

### **Additional Purposes**

The computer systems and software procedures used to operate this website acquire, during their normal operation, some personal data whose transmission is implicit in the use of protocols for internet communication. This information is not collected to be associated with identified interested parties, but by its very nature, it could, through processing and association with data held by third parties, allow users to be identified.

This category of data includes the IP addresses or domain names of the computers used by users to connect to the site, the addresses in URI (Uniform Resource Identifier) notation of the requested resources, the time of the request, the method used in submitting the request to the server, the size of the file obtained in response, the numeric code indicating the status of the response given by the server (successful, error, etc.), and other parameters relating to the operating system and the user's IT environment.

These data are used for the sole purpose of obtaining anonymous statistical information on the use of the site and checking its correct functioning, and they are deleted immediately after processing.

The data could also be used to ascertain responsibility in the event of hypothetical crimes causing computer damage to the site.

## **PLACE OF TREATMENT**

The data will be processed by the data controller at its registered office and operational headquarters in Garlate (LC).

## **REFUSAL TO PROVIDE DATA**

The interested party can refuse to give the Owner their navigation data. To do this, cookies must be disabled, following the instructions provided by the browser in use. Disabling cookies can make navigation through the site's features worse.

## **DATA RECIPIENTS**

No data derived from the web service (such as navigation data specified above and cookies) is communicated or disseminated (save communication to judicial or police bodies if necessary).

The data is processed by personnel specifically appointed in writing to process the data (staff), administrative and public relations officers also external to the Company, systems management officers, information staff also external to the Company who can also perform system administrator functions, and in this case, marketing sector personnel also external to the Company, interns, data processors and their collaborators, persons in charge of the specific sector to which a request is addressed, are appointed as such, and site management



personnel also external to the Company) only if the processing is necessary for the performance of their duties by carrying out only the operations necessary for the performance of the duties themselves.

They can also be processed by data processors (even companies external to the Company that carry out shipping, marketing, server management, and storage activities). Outside companies can also process the data through specially appointed in-writing officers who can carry out the same activities and process the data for the same purposes, for which the managers have been appointed by the **Sim-Patia Social Cooperative**.

The data provided by the user may be communicated to subjects for whom there is an obligation to communicate pursuant to the law or a need for communication to assert a right of the company to the bodies in charge.

## **STORAGE TIMES**

The Data are processed for the time necessary to perform the service requested by the User, or for purposes described in this document.

The User can always, at any time, request the interruption of the Treatment or the cancellation, and/or the Data limitation.

## **DATA TRANSFER**

The Data Controller does not transfer personal data to third countries or international organizations.

## **WITHDRAWAL OF CONSENT**

With reference to Article 23 of Legislative Decree 196/2003 and to Art. 6 of the GDPR 679/16, the interested party can revoke the consent at any time.
